## GENERAL INFORMATION

TILL-IT® FLUID CARB®-S 26-0-0 is designed for soil applications to prevent or correct nitrogen and sulfur deficiencies in a wide range of crops. It contains a DCD nitrification inhibitor to maintain nitrogen in the ammonium form for reduced leaching loss potential. This product also contains humic acids and may enhance nutrient uptake efficiency.

It should be used as part of a comprehensive Total Nutrition System® for optimizing soil/nutrient conditions for plant growth, development, yield and quality.

## DIRECTIONS FOR USE

Apply TILL-IT FLUID CARB-S 26-0-0 using recommended rates and directions with your nutrient management plans for nitrogen. Apply via broadcast, banding, or through irrigation on all row crops and permanent crops. Placement 2-4 inches below and to the side of seed placement is recommended; do not apply directly on seed.

**ROW CROPS:** Apply 5-60 gallons per acre, as a broadcast, injection, or through irrigation. Incorporation within 3 days is recommended.

**OTHER CROPS:** Apply 5-50 gallons per acre, as a broadcast, drip-injection, or band. Incorporation within 3 days is recommended.

**COMPATIBILITY:** Do not mix TILL-IT FLUID CARB-S 26-0-0 with calcium fertilizers or with low pH solutions. Proposed mixtures should be evaluated in a jar test before full scale use. Consult with your local Wilbur-Ellis representative for further information.
