#### DIRECTIONS FOR USE

TILL-IT HUMICAN may be used on all tree, vine, field, row or vegetable crops. SOIL APPLICATION DIRECTIONS:

For most crops, TILL-IT HUMICAN can be applied at 10-50 gallons per acre as a broadcast, band, or through irrigation.

For young trees, use up to 25 gallons per acre starting at first leaf. Apply TILL-IT HUMICAN every 3-4 weeks as needed throughout the season.

For mature trees, use up to 50 gallons per acre. Apply TILL-IT HUMICAN as needed throughout the season.
