TILL-IT® K-RUSH™ 22-0-3 is designed primarily for soil applications to prevent or correct nitrogen and potassium deficiencies in a wide range of agronomic crops. Its use is suggested as a supplement to a regular, balanced fertilizer program to enhance yields and improve quality. Application of this product is a means of obtaining a quick response to needed elements.

TILL-IT K-RUSH 22-0-3 should be used as part of a comprehensive Total Nutrition System® for optimizing soil/nutrient conditions for plant growth, development, yield and quality.

DIRECTIONS FOR USE

TILL-IT K-RUSH 22-0-3 may be applied on all tree, vine, field, row, or vegetable crops by broadcast, banding, or irrigation methods. Apply using recommended rates according to site nutrient management plans for nitrogen.

ROW CROPS: Apply 5-35 gallons per acre, as a broadcast, injection, or through irrigation. Placement 2-4 inches below and to the side of seed placement is recommended; do not apply directly on seed. Incorporation within 3 days is recommended.

OTHER CROPS: Apply 5-35 gallons per acre, as a broadcast, drip-injection, or band. Incorporation within 3 days is recommended.

COMPATIBILITY: TILL-IT K-RUSH 22-0-3 can be applied alone or with compatible agricultural chemicals. Proposed mixtures should be evaluated in a jar test before full scale use.
