TILL-IT LIGHTSWITCH 15-14-2 is designed primarily for starter or preplant incorporated applications to prevent or correct nutrient deficiencies in a wide range of agronomic crops. It contains DCD nitrification inhibitor to maintain nitrogen in the ammonia form for reduced leaching loss potential.

TILL-IT LIGHTSWITCH 15-14-2 should be used as part of a comprehensive Total Nutrition System® for optimizing soil/nutrient conditions for plant growth, development, yield and quality.

DIRECTIONS FOR USE

Apply TILL-IT LIGHTSWITCH 15-14-2 using recommended rates and directions with your nutrient management plans. Apply via broadcast, banding or through irrigation for row crops and other field crops. Placement 2-4 inches below and to the side of the seed placement is recomended. DO NOT APPLY DIRECTLY TO THE SEED. Consult with a Wilbur-Ellis representative for rates specific to your crop and conditions.

ROW CROPS: Apply 10-30 gallons per acre, as a broadcast, injection, or through irrigation. Incorporation within 3 days is recommended.

OTHER CROPS: Apply 5-25 gallons per acre, as a broadcast or banded. Incorporation within 3 days is recommended.

COMPATIBILITY: This product can be applied alone or with compatible agricultural chemicals. Proposed mixtures should be evaluated in a jar test before full scale use.
