## **GENERAL INFORMATION**

TILL-IT® LOFT™ CALCIUM is designed primarily for soil applications to prevent or correct calcium deficiences in a wide range of agronomic and ornamental plants. Its use is suggested as a supplement to a regular, balanced fertilizer program to enhance yields and improve quality.

Application of **TILL-IT LOFT CALCIUM** is a means to obtaining a quick response to calcium. **TILL-IT LOFT CALCIUM** should be used as part of a comprehensive Total Nutrition System® for optimizing soil/nutrient conditions for plant growth, development, yield and quality.

### **DIRECTIONS FOR USE**

**TILL-IT LOFT CALCIUM** may be applied on all tree, vine, field, row or vegetable crops by ground or fertigation application. Timing of treatments should be based on crop nutrient demand, prevailing environmental conditions, plant tissue analysis data or other information that indicates a need for supplemental calcium. **TILL-IT LOFT CALCIUM** contains chloride, and should not be applied on chloride sensitive soils or crops.

**SOIL APPLICATION:** Apply 1-10 gallons per acre per application, up to a total of 70 gallons per season for most crops through drip, fertigation or soil application. For tree fruit, apply 2-5 gallons of **TILL-IT LOFT CALCIUM** weekly for a total application of 30-50 gallons per season. Multiple applications can be beneficial.
