GENERAL INFORMATION

TILL-IT Restor-N 20-0-0 is designed for soil applications to prevent or correct nitrogen and sulfur deficiencies in a wide range of agronomic crops. This product contains humic acids which may enhance micronutrient uptake. It should be used as part of a comprehensive Total Nutrition System® for optimizing soil/nutrient conditions for plant growth, development, yield and quality.

DIRECTIONS FOR USE

TILL-IT Restor-N 20-0-0 may be applied on all tree, vine, field, row, or vegetable crops by broadcast, banding, or irrigation methods. Apply using recommended rates according to site nutrient management plans for nitrogen.

ROW CROPS: Apply 5-40 gallons per acre as a broadcast, injection, or through irrigation. Placement 2-4 inches below and to the side of seed placement is recommended; do not apply directly on seed. Incorporation within 3 days is recommended.

OTHER CROPS: Apply 5-40 gallons per acre as a broadcast, drip injection, or band. Incorporation within 3 days is recommended.

COMPATIBILITY: Do not mix TILL-IT Restor-N 20-0-0 with calcium fertilizers or with low pH solutions. Proposed mixtures should be evaluated in a jar test before full scale use. Consult your local Wilbur-Ellis representative for further information.
