GENERAL INFORMATION

TRACITE® CROP MIX is a chelated micronutrient designed for foliar or soil application. It is recommended for use as an additive in dry or liquid fertilizers and is compatible with most of the herbicides, insecticides and agricultural chemicals that can be utilized in combination with liquid fertilizers. TRACITE® CROP MIX may not be compatible with some liquid fertilizer formulations. A pre-mix "jar test" is recommended prior to mixing with liquid fertilizer to check compatibility.

NOTE: TRACITE® CROP MIX cannot be used in liquid fertilizers which contain orthophosphates

RECOMMENDED CROPS

TRACITE® CROP MIX can be applied to the following crops: Vegetables, fruit, row crops, deciduous fruit and nut trees, citrus trees and commercial turf and ornamentals.

APPLICATION AND MIXING GUIDE

Rates and timing of applications are dependent on local conditions and should always be made as a result of soil and/or plant tissue analysis and in conjunction with your local agricultural authority. TRACITE® CROP MIX may be applied by ground or aerial application. Use enough water for thorough uniform coverage of foliage or soil. Thorough coverage is necessary for best results and the addition of a nonionic surfactant such as INDUCE® is recommended.

MIXING: In any mixing operation, TRACITE® CROP MIX should be introduced in the following sequence:

- 1. Water
- 2. TRACITE® CROP MIX
- 3. Other Fertilizers or Pesticides

In mixtures where a compatibility agent is suggested, a product such as BUFFER P.S.™ is recommended. Local climatic conditions, infestations and other factors affect the performance of any insecticide, fungicide and nutritional spray. Therefore for specific use, consult your local Helena Chemical Company representative or your local agricultural extension agent.
