Ultra-Lite® helps herbicide formulations work better by guarding against hard water antagonism. Ultra-Lite® adds ammonium to help increase plant uptake and translocation of herbicide through the cuticle and phloem of the plant. Ultra-Lite® makes herbicides work better, faster and longer than many other adjuvant formulations.

DIRECTIONS FOR USE

Prior to use read all directions on this label and on the label of the product used. The product label for specific usages and restrictions have precedence over directions for uses referred to on this label.

MIXING INSTRUCTIONS

SHAKE WELL OR RECIRCULATE BEFORE USE

1. Fill sprayer 1/3 to 1/2 full of water
2. Add dry flowables or dispersible granules
3. Add emulsifiable concentrates
4. Continue to agitate until tank is 3/4 full
5. Add Ultra-Lite® last to the agitating spray tank
