APPLICATION RATES

SOIL INCORPORATION: Use 1.2-4.8 kg/cu yard of growing media.

TOP DRESS: Use 1.5-6 g/L of growing media.

NOTE: Since plant varieties are numerous and may react differently, test the product on a small scale before making large-scale applications.

APPLICATION DIRECTIONS

Apply Valena to help with the growth of plants by:

SOIL INCORPORATION: Incorporate the desired rate of material to the growing media and mix thoroughly until completely dispersed. **TOP DRESS:** Sprinkle the desired rate on the top of the growing media around the base of the growing plant. Water Valena in by use of standard irrigation practices to hydrate and distribute the product into the growing media. Sub-irrigation is not recommended for this type of application.

NOTE: Valena is not water soluble, do not include Valena in an irrigation system.
