FIRST AID

Call a poison control center or doctor immediately for treatment advice. Have the product container or label with you when calling a poison control center or doctor, or going for treatment.

GENERAL INFORMATION

VERACITY™ ELITE II is a drift reduction and water conditioning agent formulated specifically for dicamba tank mixes to reduce off-target drift. **VERACITY ELITE II** imparts a neutral pH. **VERACITY ELITE II** can eliminate antagonism of the spray tank caused by hard water minerals such as calcium, iron and magnesium. The surfactant ingredient in **VERACITY ELITE II** improves spray droplet spreading and penetration into the targeted leaf surface. **VERACITY ELITE II** provides humectancy to spray droplets resulting in a slower drying time for enhanced uptake of active ingredients. **VERACITY ELITE II** can be used for a wide range of pesticide and nutrient spray mixtures when accompanying labels recommend water conditioners and spreader-wetter adjuvants.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Storage: Store in a cool well-ventilated place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. For optimal product quality, store between 40° and 90° F.

Disposal: Dispose of contents in container to an approved waste disposal facility in accordance with all local, regional, national, international regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations. DIRECTIONS FOR USE

Use only if a nonionic surfactant (NIS), water conditioner, drift reduction technology (DRT), and deposition agent are allowed or not excluded on the label. **VERACITY ELITE II** does NOT contain ammonium sulfate (AMS).

NOTE: When combining new or unfamiliar components in any tank mix, the applicator should conduct phytotoxicity and jar tests to ensure compatibility and avoid damage to non-targeted species. Always follow the directions on the most restrictive active ingredient label. Tank mixtures should only be applied within the label recommendations of every product in the tank mixture.

USE RATES

For use with herbicides registered for use for agriculture, forestry, and industrial, municipal, ornamental, right-of-way, turf, non-cropland and other use.

Prior to using **VERACITY ELITE II**, the user or application advisor must have experience with the combination of active ingredients or must have conducted a phytotoxicity trial.

VERACITY ELITE II may be applied by ground, CDA or aerial spray equipment.

General Use: Use 2 to 8 pints per 100 gallon of spray mixture (0.25% v/v to 1.0% v/v).

For Use With Engenia™: The recommended use rate is 5 pints per 100 gallons.

For Use As A Drift Reduction Agent With XtendiMax®: Use 5 pints per 100 gallons.

DO NOT USE VERACITY ELITE II AT A RATE TO EXCEED 1% WV OF FINISHED SPRAY TANK MIXTURE.

TANK MIXING

Prior to any pesticide application, all spray equipment must be thoroughly cleaned. Carefully observe all tank cleaning directions on the pesticide label. Do not mix **VERACITY ELITE II** with undiluted herbicides.

Unless instructed otherwise by accompanying pesticide label instructions, fill spray tank 1/2 full with water, add **VERACITY ELITE II** first then continue filling tank. Add remaining pesticide or nutrient ingredients consistent with respective label directions.
