GENERAL INFORMATION

VERSATILE® IRON-SHIELD® II is a liquid micronutrient iron product chelated with EDDHA for maximum stability and effectiveness. This product is safe for applications where soil chemistry is prone to produce iron chlorosis. It is stable across a wide range of soil or spray tank solution pH levels.

This product should be used in a comprehensive Total Nutrition System® for optimizing soil/nutrient conditions for plant growth, development, yield and quality.

DIRECTIONS FOR USE

VERSATILE IRON-SHIELD II may be applied as an in-furrow treatment, soil injection, surface dribble or spray, fertigated with irrigation water, impregnated on dry fertilizer, or applied as a soil drench in new plantings.

SOIL APPLICATIONS: This product may be applied with pop-up or starter fertilizers, side-dress or water-run fertilizers, broadcast or banded. Follow the mixing directions above. Apply 2-4 quarts per acre. Higher rates may be used if needed.

VERSATILE IRON-SHIELD II may be sprayed over the top of seed beds. Dilute 1-4 quarts in sufficient water to treat one acre and band or dribble over the top of seed beds.

This product may be used in new orchard or vineyard plantings as a drench. Dilute 0.5 fl oz per tree or vine in the desired amount of water and apply to the planting site as a drench.

VERSATILE IRON-SHIELD II may be used in transplant water when planting vegetable or other annual transplants. Dilute 1-2 pints in the desired amount of transplant solution for one acre and apply at transplanting.

FERTILIZER IMPREGNATION: This product may be used to coat dry fertilizers to maximize distribution uniformity of the desired micronutrients. Rates as high as 1.5 gallons per ton may be used depending on the dry fertilizer to be coated, blender and prevailing environmental conditions.

It may be applied through fertigation equipment and will not foul low volume irrigation systems or plug emitters.

This product may be applied with other VERSATILE products or as a stand-alone treatment. Repeated applications at reduced rates may be more efficient than single higher rate applications. Soil-applied is recommended at 1-4 quarts per acre per application for all crops.

COMPATIBILITY

VERSATILE IRON-SHIELD II offers exceptional tank mix compatibility with most slightly acidic to alkaline nutrient sources and plant protection products. Some strong phosphate liquid fertilizers such as 6-24-6 and 10-34-0 can negatively affect the suspension chemistry of this formulation. When mixed directly with these types of products, dilute the desired rate of VERSATILE IRON-SHIELD II with an equal volume of water or UAN solution before adding the fertilizer.

This product will lose chelate activity if combined with strongly acidic fertilizers such as phosphoric acid, sulfuric acid or urea sulfuric acid. Consult with your local ag representative on compatibility with other spray materials. Always jar test new combinations for compatibility before field mixing.
