### APPLICATION RATE RECOMMENDATIONS

Use rate as a Drift and Volatility Reducing Agent with Dicamba Tank Mixes:

Use Volacept D + V at 1.0 gallons per 100 gal spray mixture.

Mixing: To a clean spray tank add sufficient clean water to fill the tank to % full. Be sure to agitate the tank during mixing and application. Add Volacept D + V to the spray mixture prior to adding the pesticide(s) and other adjuvants. Finish with remaining water and maintain agitation to mix. Be sure to allow sufficient time for mixing prior to application. When using a tank mix for the first time, prepare a jar test to assess the mixture for compatibility.
