FIRST AID

DIRECTIONS FOR USE

TURFGRASS: For maintenance of turfgrass, use 4.8 pounds of WIL-GRO[®] HYBRID SPECIAL per 1,000 sq. ft. or 210 pounds per acre. For repair of damaged turf (such as divot repair, pet damage, traffic wear, insect or disease damage and/or drought stress) use 4.8 pounds per 1,000 sq. ft. or 210 pounds per acre. For preplant, over-seeding, newly seeded or sod establishment, use 7.2 pounds per 1,000 sq. ft. or 310 pounds per acre.
HYDRO-SEEDING: Add 3 pounds of WIL-GRO HYBRID SPECIAL to the hydro-seeding tank per 1,000 sq. ft. of mulch/seed mix coverage.
GROUNDCOVER, FLOWERBEDS, VEGETABLE GARDENS: Incorporate 12 ounces of WIL-GRO HYBRID SPECIAL per 100 sq. ft. or 7.2 pounds per 1,000 sq. ft. into soil before planting. Use 8 ounces per 100 sq. ft. or 4.8 pounds per 1,000 sq. ft. for established or mid-season application. For corn, apply 1 pound per 100 sq. ft.
COMMERCIAL FIELD-GROWN NURSERIES AND CHRISTMAS TREE PLANTATIONS: Broadcast 350 pounds of WIL-GRO HYBRID SPECIAL per acre. If side-dressing or banding, use 3 to 4 times less per acre in a directed application or 85 to 110 pounds per treated acre. For first year transplants, broadcast 175 pounds per acre.
 For best performance, apply to dry turfgrass and water after application. Do not apply directly to an impervious surface or to ground that is frozen. Sweep or blow off any residual material on adjacent concrete, patios or walkways after application. Keep away from pools, ponds, etc. Do not contaminate potable water.
