### DIRECTIONS FOR USE

**TURFGRASS:** For newly seeded turf, apply 15 pounds per 1,000 sq. ft. or 650 pounds per acre directly prior to or immediately after seeding. For new sod, apply 10 pounds per 1,000 sq. ft. under and 5 pounds over the sod, and water well.

**FOR RHODODENDRONS, AZALEAS, CAMELIAS, AND EVERGREEN SHRUBS:** Apply 3-4 ounces around the dripline of the plant 2 times per year; in the spring and fall.

**TREES AND SHRUBS:** When planting trees and shrubs from nursery container stock in 1-5 gallon containers, mix 1-2 ounces of **WIL-GRO<sup>®</sup> PRO PERENNIAL PLUS** in the bottom of the planting hole and 1-2 ounces around the dripline.

**ROSES:** Apply 3-4 ounces per plant every 6 weeks from spring through fall.

**FLOWERS AND BEDDING PLANTS:** Apply 15 pounds per 1,000 sq. ft. or 1.5 pounds per 100 sq. ft. 3-4 times during the growing season. Close plant spacings may require higher fertilization rates. Apply to soils that are moist through the root zone. Wash off foliage.

For best performance, apply to dry turfgrass and water after application. Do not apply directly to an impervious surface or to ground that is frozen. Sweep or blow off any residual material on adjacent concrete, patios or walkways after application. Keep away from pools, ponds, etc. Do not contaminate potable water.
