GENERAL INFORMATION

Yoduo is a water-soluble fertilizer containing nitrogen and secondary and micronutrients sulfur, boron and zinc. *Yoduo* can be used in combination with water soluble plant nutritional products formulated for foliar or drench applications. It may be applied alone or in tank mixes containing other fertilizers. *Yoduo* is believed to be compatible with most agricultural water-soluble plant nutritional products. If physical compatibility with another fertilizer product is unknown, use a jar compatibility test. When applying *Yoduo* as a foliar spray, always use a spreader penetrant.

DIRECTIONS FOR USE

Transplanted Crops: Apply *Yoduo* as a drench application immediately before or after transplanting followed by up to 3 foliar applications at 5-7 days before flowering, and then at 10 day intervals for the remaining applications.

Seeded Crops: Apply *Yoduo* in 3-4 foliar applications at 5-7 days before flowering and then at 10 day intervals for the remaining applications.

Permanent/semi-permanent Crops: Apply *Yoduo* in 3-4 foliar applications at 5-7 days before flowering and then at 10 day intervals for the remaining applications.

Application Rates: Apply 13.7 – 27.4 fl. oz./acre (1-2 liters/hectare) at each application.

Crops: *Yoduo* can be applied to all crops including but not limited to: brassica (cole) vegetables, beans, berries, cereals, citrus, cucurbits, fruiting vegetables, grapes (raisin, table and wine), greenhouse vegetables, leafy vegetables, nurseries, ornamental trees, shrubs and flowers, root and tuber vegetables, row crops, strawberries, tree fruit and nuts.

Mixing Instructions: Fill the tank half full with water and then add *Yoduo* with agitation running. Add other tank mix partners and the remainder of the water.
