Zinc EPC is a concentrated and highly available form of zinc in an Enhanced Peptide Chelation system to improve availability and reduce leaching in a wide range of pH and soil environments intended for use as part of a starter fertilizer system with Farmer's First Inhabit P as a more compatible alternative to EDTA and other traditional chelated zinc alternatives.

DIRECTIONS FOR USE:

Read all label directions carefully before using this product. This product is intended for use as a zinc treatment in all soils and crops. Results are best when applied directly in the soil or root one. Do not exceed the recommended application rate for the product.

TIMING & COMPATIBILITY:

Intended for soil application only.

MIXING INSTRUCTIONS:

Always start with equipment that has been thoroughly cleaned. Fill the tank with at least 50% of the final water volume unless otherwise stated on the specific product label. For any tank mix partners other than Inhabit PTM confirm compatibility with jar test first THEN while the carrier is agitating. add tank mix ingredients in the following order:

- 1. Antifoam and / or compatibility agent
- 2. Dry formulations (WP, DF, WDG, SG, SP) and ammonium sulfate
- 3. Flowable formulations (F & FL), liquid concentrates or suspensions (LC,
- 4. Emulsifiable concentrates (E or EC)
- 5. Add Inhabit P then add Zinc EPC and other soluble liquids (S or SL)
- 6. Surfactants, water conditioners and other adjuvants
- 7. Finish filling and continue agitation

STORAGE AND DISPOSAL:

Store in a dry place at temperatures between 39°F and 110°F. Store in a safe manner. Store in original container only and keep tightly sealed when not in use. Do not contaminate water, food or feed by storage, disposal or cleaning of equipment. Dispose of unused product and empty containers in accordance with federal, state and local regulations.
